Aditi's experience over the past 16 years spans multiple industries from Financial Services to Media & Entertainment to Information Technology.

Her roles have ranged from implementing human resource management systems and establishing fundraising processes for Greenpeace, an international environmental nonprofit to leading the resource development function at Leonard Cheshire International, a global disability rights charity to generating advertising sales for a commercial radio station formerly managed by BBC worldwide.

Aditi holds a post graduate degree in Applied Psychology with a specialization in Organizational Behavior and Industrial Psychology. She is an Indian national who currently lives and works in Hong Kong.
